

**Town of Clearfield
Caucus
January 17, 2007**

Town of Clearfield Caucus was held Wednesday, January 17, 2007. The following were in attendance: Nancy Adler, Ron and Marge Bailey, Barbara Baldwin, Jody Bigalke, Ted and Janet Bova, George and Kathy Davis, Doug Duray, Gene and Sharon Halverson, Louise Hemenway, Ron Lauden, Lucille Mentzel, Dora Modjeski, Janet Prudhomme, Jim and Cindy Suzda, John and Jill Walston, Ernest Westrich, and Otto and Carol Wilkinson.

Town Chairman Doug Duray called the Caucus to order at 7:00pm. It was noted that the meeting had been properly publicized and posted.

Motion by Lucille Mentzel, second by Louise Hemenway to nominate Sharon Halverson to chair the Caucus. Motion carried. Halverson appointed Louise Hemenway and Janet Prudhomme to count votes and Lucille Mentzel to write down the names and votes on the poster board. Sharon announced that the following Town offices were to be filled at the April 3, 2007 election: Chairperson, two Supervisors, Clerk, and Treasurer. There were 23 voters present.

Voting was opened for the position of Town Chairman. Doug Duray received 6 votes and Ron Bailey 16 votes for position of Town Chairman. Their names will appear on the ballot.

Voting for the position of Town Clerk was opened. Kathy Davis received 7 votes, Janet Bova 10 votes, and Jill Walston 6 votes. Halverson announced there must be a run-off vote between the 2 lowest vote-getters in order to determine who would appear on the ballot. The run-off vote resulted in 8 votes for Kathy Davis and 15 votes for Jill Walston. It was announced that Janet Bova and Jill Walston would appear on the ballot.

Voting for the position of Town Treasurer was opened. Cindy Suzda received 21 votes and Barbara Baldwin 1 vote. Baldwin declined. Cindy Suzda will appear on the ballot for Treasurer.

Voting for position of Town Supervisors was opened. The following received votes: Ron Lauden 18; Jim Suzda 20; Doug Duray 1; Ron Bark 2; and George Davis 1. Both Doug Duray and George Davis declined. Ron Bark will be contacted by the Clerk regarding his nomination. If Ron Bark accepts the nomination, he will appear on the ballot with Ron Lauden and Jim Suzda.

The ballots were then certified and Notice of Nominations and appropriate forms were provided to all candidates in attendance. All forms were filled out and returned to the Clerk January 17, 2007 by those in attendance. Ron Bark will be sent the nomination forms on Thursday, January 18, 2007 if he accepts his nomination.

Motion by Doug Duray, second by Carol Wilkinson to close the Caucus. Motion carried. The Caucus was adjourned at 7:25pm.
