

**REVISION OF ORDINANCE #5
ORDINANCE TO CONTROL
ANIMAL NUISANCES IN THE
TOWN OF CLEARFIELD**

I. The Town Board will investigate all complaints brought to their attention verbally or in writing.

II. Animal Nuisance defined:

A. An animal **HABITUALLY** running at large without its owner's supervision.

B. Any stray animal whose owner is unknown.

C. Any unlicensed animal that is required by State or County Statute to be licensed.

D. Any animal who chases or causes injury to people, domestic animals, farm animals, deer or property.

III. ENFORCEMENT:

A. Complaints, written or verbally, must be made to the Town Board, stating the nature of the complaint and the name of the complainant.

B. The animal's owner, if known, will be contacted and a request will be made that the animal be confined to the owner's property.

C. Accumulation of 3 (three) or more complaints within in a 3 (three) month period of time will result in a citation being issued.

IV. ANIMAL LICENSING:

A. It shall be unlawful for any person to harbor or permit to remain on his property any animal that is not currently licensed that is required by law to be licensed.

V. PENALTIES:

Any person who shall violate any provision of this ordinance shall be subject to a forfeiture of not less than \$10.00 (ten) nor more than \$100.00 (one hundred) per violation.

VI. This ordinance shall be in full force and effect from and after its passage at a regularly scheduled Town Board Meeting and Publication.
